Dear Mr. Bahrami:

We have reconsidered your request for a jurisdictional determination for the Lake Joallan subdivision project site. This approximately 67.6-acre site is located adjacent to the San Joaquin River near Cardella Drive, Firebaugh, in Section 33, Township 12 South, Range 14 East, MDB&M, Latitude 036° 50′ 44.2″, Longitude 120° 26′ 30.5″, Fresno County, California.

Following review of available information and in consideration of Corps of Engineers' Headquarters direction provided in a memorandum dated December 22, 2006, we are disclaiming jurisdiction over the 26.22-acre lake and the 3.17 acres of wetlands on this site. Corps Headquarters has concluded the lake and fringe wetlands are geographically isolated from the San Joaquin River, a navigable water of the Untied States. Furthermore, Corps Headquarters found that Lake Joallan would not qualify as a water of the United States under either the tests that Justice Scalia or Justice Kennedy set forth in the Rapanos/Carabell decision. This determination is case-specific and sets no policy or precedent with respect to any other decision.

This verification is valid for five years from the date of this letter, unless new information warrants revision of the determination before the expiration date.

This determination has been conducted to identify the limits of Corps of Engineers' Clean Water Act jurisdiction for the particular site identified in this request. This determination may not be valid for the wetland conservation provisions of the Food Security Act of 1985. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should request a certified wetland determination from the local office of the Natural Resources Conservation Service, prior to starting work.

This disclaimer of jurisdiction is only for the Federal Clean Water Act. Other Federal, State, and local laws may apply to your activities. In particular, you may need authorization from the California State Water Resources Control Board and/or the U.S. Fish and Wildlife Service for impacts to the federally-listed threatened or endangered species, including but not limited to giant garter snake.
